- Provided update for the Preliminary Climate Action Plan (PCAP). The County has hosted six public forums. The Preliminary CAP will be presented to the Orange County Board of Supervisors on September 24, 2024.
- Waste Infrastructure System Enhancement (WISE) Agreement will be kicking off. WISE
 will be a regional approach addressing organics & edible food recovery, regional market
 creation & development, procurement & compliance, and regional standardization and
 collaboration.

- Huntington Beach Household Hazardous Waste Center is currently closed for renovations with plans to reopen in late October. This Saturday, September 14, there will be an OC Hazardous Waste Collection event at the Huntington Beach Corporate Yard.
- Noted several successful landfill tours including: Inadata Tour, July 17, at Frank R. Bowerman (FRB); RMI Tour, August 16, at FRB; California Resource Recovery Association (CRRA), August 21 at FRB; and OCSD Emergency Management Team, September 4, at Prima Deshecha (PDL).
- On September 11, OCWR hosted a Grand Jury tour at Olinda Alpha Landfill (OAL).
- OCWR will be part of the City of Irvine's Public Meeting on September 18.
- Zone 4 construction at PDL is on track to be completed the end of 2026.
- OCWR's next Countywide Compost Giveaway will be November 7, from 7:30 a.m. to noon at all three landfills.
