Proposed Change(s): OC Waste & Recycling as the owner/operator of the Frank R. Bowerman Landfill has submitted an application package proposing some landfill operational/design changes and other updates to the Report of Facility Information prepared as a Joint Technical Document (JTD) Amendment. The JTD also includes updated Closure/Post-Closure Maintenance Plan and Non-Water Release Corrective Action Plan with cost estimates, updated tables, figures, drawings, and appendices. The proposed changes and updates include but not limited to:

- Phase VIIIA-1 completed design and construction along with the East Sliver Fill design
- Updated remaining site capacity and site life information
- Acceptance of treated wood waste
- Estimated completion of the permitted acreage for the Bee Canyon Greenery Facility
- Cessation of processed green material as diversion credit for alternative daily cover effective 2020
- Address SB 1383 submittal of a Status Impact Report to CalRecycle
- Information on abandonment of existing piezometers and inclinometers
- Installation of a sixth flare at the landfill

LEA Determination: The LEA has accepted the application after determining the proposed changes and updates do not conflict with the existing Solid Waste Facility Permit, meet applicable State Minimum Standards, and are consistent with all California Environmental Quality Act (CEQA) documents prepared for the facility.
