Call to Order

Chairman Rob Johnson called the meeting to order at 2:07 p.m. The meeting location was Discovery Cube OC, 2525 N. Main St., Santa Ana, CA.

Pledge of Allegiance

The Pledge of Allegiance was led by Commissioner Joe Soto.

Roll Call

Roll call was conducted by the Commission Clerk.

Chairman's Report

Chairman Rob Johnson shared a brief history of the partnership of OCWR and Discovery Cube, which traces its roots to California state recycling legislation – AB 939, which launched a new era of recycling by mandating a 50 percent diversion rate. Partnering with the Cube enabled OCWR to deliver mandated educational messaging.

He also encouraged Commissioners to attend events when possible, such as America Recycles Day Eco Challenge collection held in November and to take a landfill tour. The chairman reminded Commissioners that the Ethics Training course must be completed and submitted to the Ethics Office by December 31, 2018. Commissioners who fail to meet the deadline will vacate their seat.

Chairman Johnson offered congratulations to elected officials on the Commission: David Shawver for being elected Mayor of Stanton; Mark Tettemer for being elected to the Lake Forest City Council; Beth Haney for being named Yorba Linda Mayor Pro Tem.

Director's Report

Director Tom Koutroulis reported:

- San Juan Capistrano cooperative agreement approved by the Board of Supervisors. Capacity in Zone 1 to 2050; Zone 4 to 2102.
- Next Countywide Integrated Waste Management Plan (CIWMP) update is due March 2021. Update will include organic waste management.

- Major capital projects. New 30-year capacity fill zone at FRB completed. Final Phase at Prima under construction.
- Passed all our monthly LEA inspections this year.
- Completed another USCC composting training; OCWR selected as a training site

He also commended and thanked Rob Johnson for her service as Commission Chair.

Agenda Item 2 – OC Waste & Recycling's FY 18/19 Financial Report Karalyn Meeh, Section Manager, Budget, Purchasing & Landfill Administration

This report presents the financial status of OC Waste & Recycling as of the second quarter of FY 18/19 (ending December 31, 2018). Included in the report is financial information related to tonnage, expenditures, revenues, and cash balances.

System Tonnage

Total OC Waste & Recycling system tonnage received as of the second quarter of FY 18/19 was 2,581,471 tons, consisting of 1,613,529 in-county tonnage and 967,942 importation tonnage. By landfill site, tonnage as of second quarter was as follows:

Olinda Alpha Landfill

In-county tonnage 584,464 (36%) of total in-county tonnage Importation tonnage 464,008 (48%) of total importation tonnage

Frank R. Bowerman Landfill

In-county tonnage 815,722 (51%) Importation tonnage 439,009 (45%)

Prima Deshecha Landfill

In-county tonnage 213,343 (13%) Importation tonnage 64,924 (7%)

Revenues

As of the second quarter of FY 18/19, revenue recorded in OC Waste & Recycling's Enterprise/Operating (Fund 299) was \$54,116,882 versus the modified revenue budget of \$146,998,240.

Revenue recorded in OC Waste & Recycling's Capital Project Fund (Fund 273) was \$290,087 versus the modified revenue budget of \$29,100,000.

Revenue recorded in OC Waste & Recycling's Importation Net Revenue Sharing Fund (Fund 295) was \$23,700,383 versus the modified revenue budget of \$52,281,097.

Sources of revenue received as of the second quarter of FY 18/19 included:

- \$72,372,274 Tonnage Revenue (94.67% of total revenue received)
- \$1,817,434 Interest Income (2.06%)
- \$1,372,676 AB 939 Surcharge Revenue (1.79%)
- \$1,298,811 Leases & Royalties (0.45%)
- \$157,062 Other Revenue (0.02%)

Expenditures

Expenditures and encumbrances recorded in OC Waste & Recycling's Enterprise/Operating (Fund 299) as of second quarter of FY 18/19 totaled \$50,504,235 or an approximate 32.7% of the modified expense budget of \$ 154,240,431.

Expenditures and encumbrances recorded in OC Waste & Recycling's Capital Project Fund (Fund 273) as of second quarter of FY 18/19 totaled \$10,539,581 versus a modified expense budget of \$49,085,517.

Expenditures and encumbrances recorded in OC Waste & Recycling's Importation Fund (Fund 295) as of second quarter of FY 18/19 totaled \$1,396,698 versus a modified expense budget of \$50,919,000.

As of FY 18/19 second quarter, OC Waste & Recycling's major categories of expenditures were:

- \$26,743,311 Services & Supplies (42.8%)
- \$13,169,348 Salaries & Employee Benefits (21.1%)
- \$10,530,669 Capital Projects (16.7%)
- \$8,212,555 Equipment (13.2%)
- \$3,792,290 Taxes, Fees, Assessments (6.1%)

Cash Balance and Reserves

As of December 31, 2018, the OC Waste & Recycling's Enterprise/Operating Fund 299 had a cash balance of \$ 206,034,448.

As of December 31, 2018, the OC Waste & Recycling's Enterprise/Operating Fund 299 had an available reserves balance of \$89,091,138.

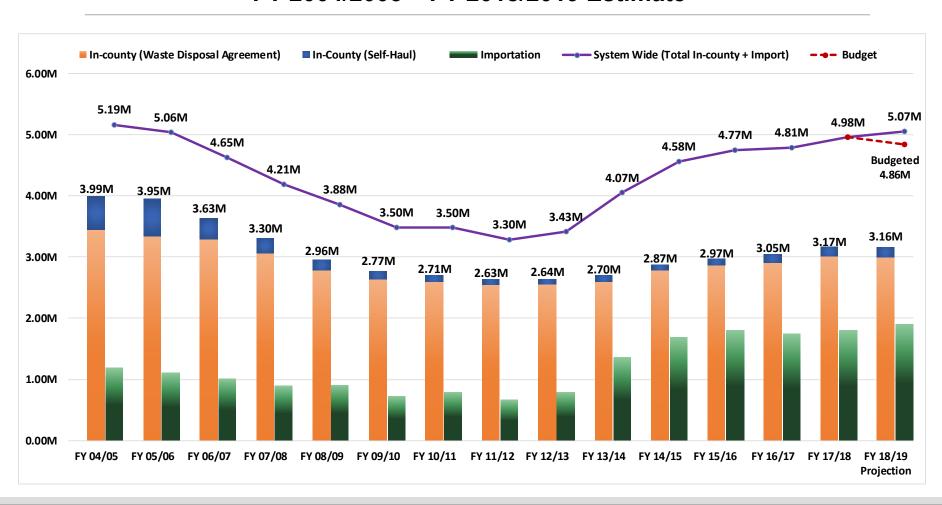

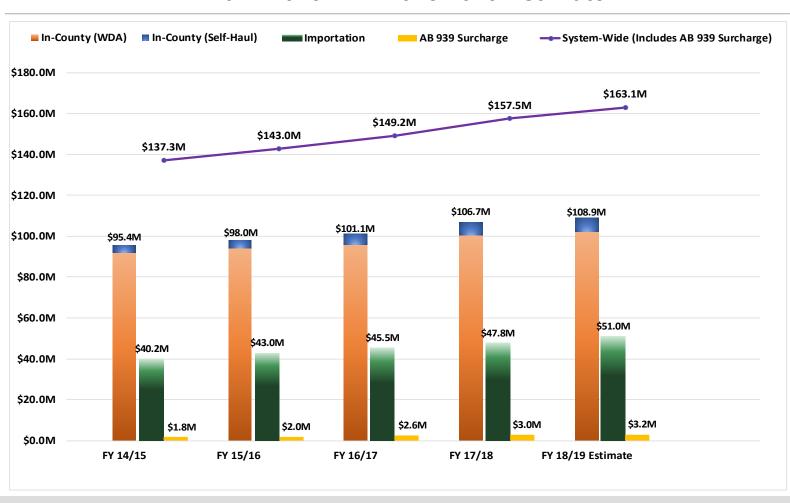
